## NARRATIVE

On January 4, 2019, I responded to 1000 W New Haven Avenue, Cumberland Farms, in reference to a disturbance.

Upon arrival I made contact with a subject, identified by her Florida Driver's License as Marina Rogers, standing next to a blue Corvette bearing Florida tag EHIT49 with a shattered driver window. While speaking with her I smelled the strong odor of alcohol coming from her. Ms Rogers advised the following in essence:

That after a verbal disagreement she broke the window to the car that her boyfriend was renting. Ms Rogers advised that she jumped out of the moving vehicle and into traffic. When asked she advised that she ran into traffic in an attempt to get hit by a car, to make her boyfriend feel guilty for cheating on her. Ms Rogers told officers several times on scene that she tried to kill herself and she did not care if she died.

I placed Ms Rogers under a Baker Act and transported her to Circles of Care.
